

Information about additional information that will be required in MSW for presentation notification for goods

From 3 June 2024 a presentation notification must be submitted for goods arriving directly to Sweden from a non-EU country by sea. To submit a presentation notification of goods, additional information will be required in the Maritime Single Window (MSW) Reportal.

MSW – what is new?

Cargo to unload

The 'Cargo to unload' tab has been complemented with the necessary information to submit a presentation notification via the MSW. The tab will consist of two parts, Presentation notification for goods and goods to be unloaded where information about goods to be unload is mandatory.

Presentation notification for goods

The requirement to present goods to customs only applies to goods that are unloaded in Sweden. Find out more about presentation notification of goods [here](#).

A presentation notification of goods should make reference to an entry summary declaration and/or proof of Union status. This will require additional information in the MSW, the new information that will be required is:

- Entry summary declaration MRN
- Transport document reference at Master and/or House consignment level
- Container
- Receptacle.

Proof of Union status in the form of a PoUS MRN or references to supporting documentation are currently submitted on the 'Cargo to unload' tab. In the future, this should be provided under 'Cargo to unload' > 'Presentation notification'. Find more information about PoUS [here](#)

The data can be provided by uploading the Excel template in MSW or manually in the interface on the cargo to unload tab. A presentation notification of goods must be submitted at the latest upon arrival and must be in place before the cargo declaration can be approved.

- **Goods to be unloaded**

Information on goods to be unloaded should still be provided on the 'Cargo to be unloaded' tab. With the change, goods to be unloaded will always be submitted in the same way as you currently report mixed goods. The information to be provided is still the same, status of the goods, weight and type of goods. If the goods are non-EU goods (N-goods), a reference to the subsequent customs procedure must also be provided. However, no references to entry summary declarations or transport documents are submitted with the goods. These are submitted under the heading 'Presentation notification'.

Information about goods to be unloaded must be provided at the latest upon arrival and must be in place before unloading can be authorised and the cargo declaration can be approved.

Information of transition period from 3 June

On Monday 3 June between 11:00-13:00, Swedish Customs and the Swedish Maritime Administration will carry out a joint planned downtime for MSW to deploy the new way of reporting notifications of the arrival of goods.

With the transition to the new way of reporting Presentation notification for goods and as a result of the change in the interface in MSW, all data in the cargo declaration (on the 'Cargo to unload' tab) will be cleared. In order to receive a decision on unloading and/or cargo declaration after the transition, the data must be registered using the new procedure.

Data registered in the cargo declaration and for which you have already received a decision do not need to be registered again.

If you need to amend the cargo declaration after arrival (ATA) or unloading/cargo declaration decision, please contact Swedish Customs' ship clearance.
